## IN THE NEWS

#### Lincolnshire country's worst for drink drive crashes

Drivers in Lincolnshire are more likely to be involved in a crash whilst under the influence of alcohol than anywhere else in the country, a national study by Road Safety Analysis has said.


The study looked into the number of car drivers who had been drinking before a police attended injury collision. The overall trend highlighted 2.7% of crashes involved drivers who were considered drunk at the wheel. Against this figure, Lincolnshire topped the drink drive rate with 71% of drivers likely to be considered over the limit than the national norm.

Car drivers from London were the least likely with a risk rate of 63% lower than the national average.

The Road Safety Analysis report said: "The vast majority of British drivers are responsible and wouldn't think twice about drinking and driving. In rural areas this is much harder with the cost of getting home safely much more expensive than in towns. Drivers are urged to plan ahead at all times of the year to have 'none for the road', reducing the temptation to drink".

The figures were broken down into police force area. The analysis was carried out on over 500,000 car drivers involved in police attended injury collisions between 2010 and 2014.

#### What the IAM say...

A recent IAM survey revealed almost 70% of people would like to see the legal drink drive limit reduced across England, Wales and Northern Ireland to the same level implemented by Scotland (reduced from 80 to 50 milligrams of alcohol in 100ml of blood in December 2014). Police Scotland confirmed they saw a 19% reduction in drivers being prosecuted for drink driving through winter compared with the previous 2 festive periods.

The IAM's CEO, Sarah Sillars said: "the IAM supports campaigns which makes the non-drinker the hero on a night out, so that everyone stays safe."

#### WINTER DRIVING EVENING

## Gary Hill's report on our November Driver Development Evening...

Thirty-four members attended the evening, and joined in with some very good feedback; some of which was very amusing.

Ashley Behan, Group Secretary and recently qualified IMI Observer, started the session by showing slides relating to adverse weather conditions that can be encountered at this time of the year. He spoke about foggy conditions, flooded sections of roads, snow and high winds. Most of those who attended knew what to do if their vehicle was covered in snow and were aware that it was an offence to use it without taking adequate remedial action.

Ashley also spoke about commercial vehicles and the restrictions that apply to them. High-sided lorries are particularly vulnerable in high winds, etc. He said that it was necessary to prepare your vehicle for the months ahead and not get caught out. Most important is the state of the tyres (considering tread depth). If you have to travel in adverse conditions you need to ensure you have enough fuel, mobile phone, warm clothes, a warm drink and a shovel in the vehicle.

Our Chief Observer, Roger Hicks, then spoke about driver development. He asked members how long it had been since they had taken their test. He suggested that those members who had passed the IAM test were far more capable on the road than those people who had not.

IPSGA (information, position, speed, gear and acceleration) was discussed; most important was planning and ensuring you could make safe progress. Eco driving was also spoken about – being in the right gear and at the right speed at all times.

Julia Vause, Treasurer of the Lincoln Group, provided the buffet and everyone enjoyed the fantastic spread. Tony Lofts organised the raffle, which was very entertaining. The next part of the evening provided an opportunity to show our members a photo-shoot of the newly appointed IAM observers who had recently taken the advanced level training test with the Head Office Chief Examiners. They had brought along the new certificates that they had received.

#### CHRISTMAS SOCIAL EVENING

Our Christmas Social Evening and Quiz was the last event in our 2015 social calendar. Several members enjoyed the evening and shared information and memorabilia about the groups history. #### **POTHOLE PROMISE**

#### Chancellor announces 'permanent' pothole fund...

The condition of local roads has been named as drivers top motoring concern, according to a report carried out by the RAC. With decreasing government grants for local authorities set for the foreseeable future, the challenge of effective maintenance for local roads has never been more real.

£15 billion will be invested in upgrading the Strategic Road Network (motorways and trunk roads), but this will not benefit local roads which make up 98% of the highway

network.

The government has estimated the cost of bringing local roads in England alone back to a state that is fit for purpose to be up to £8.6bn, whilst the industry estimate £12.16bn. The Chancellor has recently announced £6bn will be allocated for local road maintenance over the next six years; on top of this a £250 million investment will be made in a 'permanent' pothole fund. In the future highway authorities will be funded based on efficient performance,

industry best practice and adopting asset management plans (RAC, RSTA & Highways Magazine).

With this in mind, it seems likely that the condition of our local roads will continue to deteriorate over the next few years and this is something we have to accept and adapt to. As advanced motorists, we must give further attention to the changing condition of the road surface and the potential affect it will have on the vehicle.

#### Claims and funding facts...

- Lincolnshire County Council maintains the fourth largest road network in England. In the 2012/13 financial year they paid out the most for pothole damage compensation claims (LV).
- In the 2014/15 financial year local highway authorities received one pothole claim every 18 minutes (RAC).
- Of the £5 billion collected in vehicle excise duty in 2014/15, local authorities received £976 million for road maintenance (RSTA).

#### Winter words from Graham Ford...

Have any of you suffered heart palpitations at the abuse of your credit card or considered filing for divorce? I also suspect the sale of "Rennies" increases dramatically about now - pie, chips and mushy peas are a much safer diet!

At this time of year my sympathies are entirely with Ebenezer Scrooge "CHRISTMAS! BAH HUMBUG!!" I say this from the point of view of an old cynic and curmudgeon who lives the life of a well ordered routine. For example – Tuesday breakfast must always be two boiled eggs after the daily elementine (for vitamin D) which, I am assured, my body needs and my bowl of cereal. Anything that disturbs this comfortable routine is anathema!

Now on a more serious note, November's meeting was interesting, first, with Ash reminding us all of winter driving and preparation techniques, although as Advanced Drivers we should have this implanted in our memories but it never hurts to be reminded. As a retired HGV driver may I reiterate a point I made: that in ice, snow or fog, give lorries, of whatever size, a wide berth. Being hit by a skidding or jack-knifing lorry is like a ball being hit by a cricket bat, cars definitely come "second".

I must confess, that during this presentation, new technology in the form of automatic headlights, wipers, etc was mentioned, I was not particularly aware of this progress, which, whilst admirable in its concept, just makes me wonder if the "skill" of driving is being reduced? Is the driver of a modern car so cocooned and surrounded by "gadgets

and gizmos" lulled into thinking no harm can and are surprised when the lights turn befall them! Have drivers lost the art of "reading the road"? Being able to discern "contaminated" road surfaces such as patches of sodden leaves, compacted snow or the worst one, black ice. Of these last two, driving skill is paramount, all the traction control, anti-lock brakes, four-wheel drive and good tyres won't help "NO GRIP = NO CONTROL"!! In these conditions sight and sound are good pointers to the road surface, is there spray coming from the wheels of the vehicle in front, can you hear the "swish" of your wheels as you can on a wet surface? If not, chances are you "AIN'T GOT MUCH GRIP"! How to deal with it? Take your foot off the accelerator and let the vehicle slow down naturally, avoid the footbrake if possible, just to reiterate, accelerate and brake gently, low revs, high gear. Fog: try, as far as possible, to keep a consistent speed and don't be "on and off" the brakes or you're likely to be shunted from the vehicle behind and if you really can't cope pull off the road at a safe point, have a breather and let the rest get on with it.

I also appreciated Roger's presentation, outlining the changes to training for all aspects of the IAM. Hopefully now prospective members will all be trained to the same high standard nationwide - no bad thing.

I spend the greater part of my driving time in and around the City and I can't help but notice the glaring discrepancies in driving skill. For example, road junctions the number of drivers who tend to "lean" a car around a junction as if they were riding a bike, don't they know what a steering wheel is for? Traffic lights are another bone of contention, some drivers seem to "nod-off"

green, often creating big gaps between vehicles instead of flowing through in an orderly and controlled manner. Another moan is that the traffic lights in Lincoln do not appear to work in a logical sequence, often causing traffic build-ups and, consequently, grid-lock and NO, I wouldn't like to try and reorganise it either!

### **KNOW YOUR STUFF**

#### Leave your engine running?

Leaving your car with the engine running whilst unattended isn't a good idea - but did you know that doing so on a public highway is an offence under the 1991 Road Traffic Act?

"Quitting", as its known, is an offence under Section 42 of the The IAM's director of standards, Mark Lewis advises: act, insofar the vehicle fails to comply with further regulations under the Road Vehicles (Construction and Use) legislation

which requires the stopping of the engine when the vehicle is stationary, for the prevention of noise. **Emergency vehicles** are exempt-provided they are responding to an emergency!

The police can offer words of advice or issue the offender with a fixed penalty notice of £30.

As well as the noise issue, if you fail to lock your car with the spare set of keys it could make easy picking for thieves and invalidate your insurance.


