2018 Group Subscription Due

Just a reminder to **Everyone** that your Group Yearly subscription is due this month.

If you have already paid, thank you but if not please contact myself to make payment.

Annual Subscription system comes into full effect on 01 APRIL 2018, meaning that Group Subscriptions of £7.50 for EVERY Full Group Member will be due on that date. In future, subscriptions will be due on 01 April each year, whenever you used to pay under the previous Anniversary system.

If you normally pay by Standing Order, you will need to change your mandate to the bank. You may need to establish a new one, as some establishments will allow you to change the amount you pay, not the date on which it is paid. If you pay by BACS, cheque, or cash please put a note in your diary that subs will be due on 01 April EACH YEAR.

Spring Forum

Tony and myself attended the Spring forum on Saturday 7th April at IAM Headquarters in Welwyn Garden City.

We were both made most welcome by both Pat Doughty and Amanda Smith who held the meeting.

The main content of the meeting was to discuss the new General Data Protection Regulation which comes into force on the 25th May. This is going to affect everyone in the IAM and also down at group level. IAM will be sending out new contract form to all of us which will be explaining the way in which we will be using your data in the future.

Although we as a committee have yet to discuss this, it is very likely we will be following the same route. More on this in the coming month.

Also discussed at the forum was Group level sign off. This has become a success with other groups allowing the group to assess associates who do not wish to take their test with an examiner. This allows the group to sign them off. Although this will prevent them from passing with a first it will allow the associate to become a full member.

This is something our group could look at achieving in the future.
