Vehicle tax changes

From 1 October 2014, the paper tax disc will no longer need to be displayed on a vehicle. If you have a tax disc with any months left to run after this date, then it can be removed from the vehicle and destroyed.

You can apply online to tax or SORN your vehicle using your 16 digit reference number from your vehicle tax renewal reminder (V11 or V85/1) or 11 digit reference number from your log book (V5C)

Buying a vehicle

From 1 October, when you buy a vehicle, the vehicle tax will no longer be transferred with the vehicle. You will need to get new vehicle tax before you can use the vehicle.

You can tax the vehicle using the New Keeper Supplement (V5C/2) part of the vehicle registration certificate (V5C) online or by using our automated phone service - 24 hours a day, 7 days a week on 0300 123 4321.

Alternatively, you may wish to visit a Post Office® branch.

Selling a vehicle

From 1 October, vehicle tax is not transferable so you won't be able to include any remaining tax when you sell a vehicle. If you sell a vehicle after 1 October and you have notified DVLA, you will automatically get a refund for any full remaining months left on the vehicle tax. The refund will be sent to the keeper's details on DVLA records so you need to make sure that these are correct.

How to check if a vehicle is taxed

You can check if a vehicle is taxed <u>online</u>. This can also be used for rental vehicles.

Report by Stuart Earle on Master in the Making

I originally took both my IAM test and RoSPA Advanced Drivers test back in 1989 a couple of years after I had come to Peterborough. I have heard many people say "I should have done that years ago" and that echoed my thoughts.

Within a few weeks of passing my IAM test I was asked if I could help an Associate. . In those days there was no formal Observer qualification and as a willing volunteer - 1 was quickly encouraged to get going. My new associate was a Road Safety Officer and drove a fairly battered old Renault 4. I had owned such a vehicle and really enjoyed being in one again. She passed the test and I then continued to observe. I have not kept an accurate record of how many associates I have been involved in training since then but the number will well exceed 50.

As the years progressed I wanted to ensure that I kept up to the standard of driving set by the IAM. Observing is a good way of doing this. I took the Senior Observer Test about eight years ago and earlier this year took the National Observer Test which is quality assured by the IMI (Institute of the Motor Industry). This entails both a driving element and a teaching element. It is a good opportunity to have your driving skills assessed and part of the recommended route to the Masters.

When I passed my IAM test in 1989 there was a further test available called the Special Assessment but few people knew much about it and seemingly fewer actually took it. In 2011 I had the opportunity to attend a training weekend in North Yorkshire, which was designed to assess the level of interest in a re-launched Special Assessment by offering some training and discussion. I had an enjoyable

weekend and lots of driving. I had just purchased, on the day of travelling to the venue, a fairly old Alfa 156 (you have to have owned at least one Alfa in your driving life!), which added to the challenge especially somebody attempted to change its shape whilst I was having a coffee break. I was paired with Colin the IAM marketing manager at the time and since he was not a keen driver I had two of the three sessions one to one with a recently retired traffic policeman, David Heath. I had some positive feedback about my driving and some guidance on areas where I could improve.

It was some time before the new Special Assessment was relaunched as the Masters. I attended the IAM Conference in 2013 and went to a workshop on the Masters. By then I had decided that I wanted to have a go and had paid my fee. The workshop did not really enlighten me as to what the Masters would involve and I was struggling to get a sense of the standard. There was a rumour that the standard would be Police Class 1 but within the speed limits. I wondered how that level could be achieved with quite limited tuition.

The Masters quickly proved to be very popular and waiting for a Mentor was frustrating. After a few months I was told that a mentor had been found but it would be another month or so before he could start my tuition. I met Andy Greenslade up at Grantham. I had done some observer training with him in the past so knew him. He is retired Special Branch officer and has a of stories to wealth tell. Nowadays he runs his own company and also acts as a consultant for a TV company. I drove for about three hours and we covered a variety of roads around the Grantham area. It was a tiring experience but I really enjoyed the challenge pointed out to me where I needed to finesse my use of the system, avoid any brake gear overlap and make sure that I made progress where possible. The drive summary contains twelve components and Andy gave me some useful comments in each area. My own reflection after the session was that I was still getting to grips to know the standard of the Masters. I felt also that my driving style tends natural towards safety so it would need to be balanced with progress. Unfortunately due to returning to work full time Andy could not continue with the mentoring.

Our Group President Trevor Dickenson was happy to go out with me for a couple of drives which were really helpful and Trevor encouraged me to make more progress but always driving to my limit. Trevor pushed me just to the limit of my comfort zone which I needed to experience. Trevor increased my confidence and because he had been involved in developing the Masters programme I felt that a great deal of common sense was being imparted and at last I was beginning to get a grip of what was needed.

I had to chase the IAM to get another mentor appointed and eventually they were able to allocate me to Andy McManus. I had met Andy a few times in the past at IAM events and knew that his main interest was bikes. He has recently been tutoring Chaz World Davies, Superbike Champion, and the comedian Alan Davies as part of an IAM ROSPA Road Safety initiative. He was very efficient and quickly booked me three sessions. Andy left the police force a few years ago following a motor cycle accident and is now a Minister of the Baptist church at Bourne and also involved in

Learner driver training as well as being an examiner for the IAM.

My first drive out with Andy was to Cadwell Park. He instructs there sometimes. I enjoyed the drive and found that Andy's style was very relaxed and confidence inspiring. He encouraged me to question all the time and to be a "thinking" driver. Had I been undertaking an IAM test he told me that he would have given me a F1RST for the drive. Main areas to work on were applying the system to corners and to finesse my braking technique to ensure use only when necessary.

My second drive was shorter and mainly took in a trip from Bourne to Peterborough where Andy visited his favourite shop, Balderstons BMW Bikes. Free coffee was on offer and a look at the amazing machinery on show. On the return we took in some

dual carriageway and more country roads. Andy commented mainly on observation skills and timing the approach to corners. I enjoyed the session; one of my observations was that some of the techniques would be much more beneficial at speeds in excess of the limits, which of course we are unable to explore on public roads.

My third drive took in roads I did not know up in Lincolnshire. Andy commented that I sometimes used a little too much braking and that I could have used 4th gear rather than 3^{rd.} Overall he commented that my use of the system was quietly efficient and effective, my commentary was clear and concise and that I made good progress where possible. He summed up in four words: safe, systematic, smooth and progressive.

I took my test over in Northamptonshire in July and was successful in achieving a Pass at Distinction level. Andy Giddings was my Examiner. He commented that I had given an impressive drive and demonstrated that I am an accomplished driver.

I enjoyed the experience of preparing for the Masters. The popularity of the course meant waiting for a Mentor and later for a second Mentor but looking back they each had a different approach. Trevor was very helpful as always and his input was very much common sense based. I have always enjoyed driving and the experience of doing the Masters has given me a further sense of enjoyment and achievement in my driving.

2. Minutes of the last AGM held on the 7th March 2013

4. Chairman's Report.

The Chairman (SE) welcomed our President Trevor Dickenson and speaker Andy Bolton, IAM Regional Manager and all the members and thanked current committee members who have served during 2013-14 for their hard work. Thanks were also expressed to the committee and officials for their ongoing contributions to the running of the group. Events organiser Prue Lester for organising all the events, Stan Watts, who is standing down as an observer and who had served as Chairman and on the committee over many years was recognised for his contributions. A certificate of appreciation was presented in his absence to be delivered to him

later. Thanks also to Kim Harris for running the website and who is moving away from the area so is standing down from that post. Rachel Stothert, who is standing down as newsletter editor. Lastly, Hannah Caller who has stood down as observer and Young Driver Rep. on the committee.

During the year there have been a range of events including a number of interesting guest speakers as well as training events and drive outs.

It has been a successful year with 23 test passes up from 20 last year including 4 FIRSTS. The chairman expressed thanks to training co-ordinator Sandy Reid.

Group membership currently stands at 82 members. This is comprised of 64 full members and 18 Associates. Test certificates were presented to Bill Ringham and Richard Anker (FIRST) who have taken their tests recently.

5. Treasurer's Report and Adoption of the Annual Accounts.

Had been published to members and were also available at the meeting.

Bill Peck (Treasurer) delivered the Treasurer's report. At the beginning of the year we had a high balance in the group account and it was recommended by the auditor at the last AGM that we needed to reduce this by using funds for the charitable aims of the group. A group laptop was purchased for use at group meetings and admin and to enable the secretary to access the IAM DTE database which is now compulsory for all groups and will speed up enrolment and test bookings. Six SFL gift vouchers were also purchased, five to use as prizes in the Christmas draw, which it was felt would help promote the group and bring more new associates

in. The sixth is to be used as a prize in a forthcoming event for Golf Club members which it is hoped will also bring in new members. In the latter part of the year there has been a drop off in new associates reducing our income from SFL somewhat. The balance at January 31st 2014 stands at £1224.22.
